CHELAN COUNTY PUD

Formed in 1936, Chelan County PUD District No. 1 is a municipal corporation that owns and operates one of the largest non-federal, publicly owned hydroelectric generating systems, along with wind and solar resources, in the country. The PUD's 3,000-square-mile service area covers all of Chelan County and extends into four neighboring counties. Chelan PUD has grown into a multi-faceted public utility, and over the years has added water and wastewater utility services, whole-sale fiber, and telecommunications.

The PUD has numerous projects underway or in the planning stages in support of its strategic priority to "invest in assets and people."

The utility is taking a long-term view with these projects to provide value to customers for decades to come. These investments include rehabilitation of generating units at Rock Island Dam, development of a new Service Center, reliability improvements through tree trimming and line work and the recent renovation of the Rocky Reach Discovery Center. The PUD also continues to work on an accelerated fiber build-out for ultra-fast Internet service throughout most of the county.

FAST FACTS ON CHELAN PUD:

- » ~51,000 electric customers, with average retail residential rate of 3.4 cents per kilowatt hour, 2nd lowest in the nation
- » Own & operate 3 hydroelectric projects, which on average, produce 9.5 million megawatt hours of clean, reliable, low-cost, carbon emission free, power a year - enough to run a city of nearly 1 million people.
- » Chelan PUD developed one of the country's first Habitat Conservation Plans for anadromous fish. Under these landmark accords, Chelan PUD agrees to very high-performance standards of "no net impact" on Salmon and Steelhead runs passing the dams.
- » A solar leader in Washington state thanks to award-winning Sustainable Natural Alternative Power (SNAP) program.

ABOUT THE POSITION: CHIEF FINANCIAL & RISK OFFICER

The CFO is responsible for the direction, control and coordination of all financial and risk management activities. He or she oversees the District's +\$500 million investment portfolio, \$350 million debt portfolio, bond covenant compliance, State and Federal Regulatory requirements, financial reporting of +\$2 billion in assets, and +\$400 million in annual revenues. This position provides executive leadership for strategic financial planning, treasury, general accounting, forecasting, budgeting, financial reporting, accounts payable, receivables, insurance counter party credit and collateral management, energy trading back and middle offices, quantitative analysis and business intelligence and data analytics Districtwide. The CFO provides executive leadership of the enterprise risk management program to include strategic, operational, financial, market, environmental, regulatory and compliance risks.

This person will work closely with other executive level positions to develop and implement District-wide strategies.
